# Lecture series "Science from the first hands" of the regional group Berlin-Brandenburg: Lecture on Vasyl Sukhomlynsky by Dr O.V. Proskura

The lecture "Vasyl Sukhomlynskyj in dialogue with modernity" was given by Dr Olena Proskura, one of the followers of the most known Ukrainian Teachers on 12 December at the Ukrainian embassy in Berlin. Dr Proskura is a renowned expert in the field of child psychology and preschool education and a founder of numerous methodical guides (e.g. her programme "Child/ Дитина" has been adopted by a vast majority of pre-schools in Ukraine since early 90<sup>th</sup> of the last century). The lecture was devoted to the life and intellectual heritage of the true Teacher, whose most famous book "I give my heart to the children/ Серце віддаю дітям" was published in 30 languages all over the world as 54 editions. Interestingly, this work first appeared in print in Berlin in 1968, before the permission was granted to publish it in Kyiv. In Marburg, Germany, a Society of followers of Sukhomlynsky was founded back in 1990. Since 1994 there are regular readings devoted to V. Sukhomlynsky, organised by the head of the Pedagogic Society of Ukraine, Olga Sukhomlynska and the head of All-Ukrainian Association named after Sukhomlynsky, Oleksandra Savchenko.

#### First meet-up in Dresden

On 13 December a group of 12 scientists from six different Dresden scientific institutions, as well as guests from Berlin and Hanover, got together for an informal round-discussion dinner. Dresden hosts, according to some estimates, one of the largest Ukrainian research diaspora communities in Germany, especially researchers with background in physics, chemistry, material sciences and life sciences. In an informal pre-Christmas atmosphere this meeting offered a nice opportunity to get to know, exchange the experiences and views on cooperating with research partners in Ukraine, and to explore some ideas for possible future coordinated efforts. It was unanimously decided that such meetings should happen regularly and the next one is tentatively planned for February 2017. The meeting was organised by Dr Vyacheslav Khavrus (TU Dresden) and Dr Denys Makarov (HZDR), active members of the UKRAINE Network.

### Ukrainian tech start-up Polyteda Cloud won a EUR 1.2 million funding from Horizon 2020

The EU is investing into the 2-year project "Innovative Cloud-Based PV Workflow for Semiconductor Foundries" to enable Polymeda Cloud enter the European market. Its software for circuit verification checks the designs of microchips for mistakes before they go for manufacture at semiconductor factories. Polyteda Cloud is a spinoff project of Polyteda Ukraine, a company that is itself part of the high-tech holding KM Core. Majority of its staff are graduates of the renowned National Technical University of Ukraine.

The Horizon 2020 programme aims to secure Europe's global competitiveness by funding innovations, in particular by supporting SMEs. The budget for a single company ranges from 500,000 euros to 2.5 million euros; or up to 5 million euros for health-related projects. The EU will also provide the company with business coaching.

## Alexander Filippov has been awarded the Georg Forster Research Award by the Alexander von Humboldt Foundation

Professor Filippov is well known internationally for his outstanding research in the fields of theoretical and applied physics. He has made important contributions to these fields ranging from the atomic scale friction and planetary systems dynamics to the questions of biological evolution and ecology, by combining a large variety of mathematical methods with intuitive physical insight. During his stay in Germany, he intends to develop simulations of adhesion and friction behavior of various biological systems: from chameleons, clingfish to the snake skin. His models will be enhanced due to implementations of real physical parameters, obtained from experimental studies on biological systems.

Professor Filippov is hosted by Professor Stanislav Gorb at the Kiel University and by Professor Popov at the Technical University Berlin.

## Meet Fulbright Scholars 2016-2017 in Ukraine

11 researchers and four students from different fields of research and various U.S. universities, including Yale School of Medicine and Yara Arts Group in New York, will come for a research stay at a broad range of Ukrainian universities and research associations. They research projects range from investigating the heritage of Les Kurbas, a famous Ukrainian theatre director, to studying the curriculum at medical schools in Ukraine and comparing them to leading medical schools in Europe and in the U.S., from teaching a course in financial mathematics to assessing traumatic stress and resilience in Ukraine, among others. In addition seven Fulbright English teaching assistants will commence their work to support and improve teaching of English at Ukrainian universities. Furthermore two Fulbright-Clinton Scholars will contribute to important political topics: Combatting Propaganda and Connecting with Citizens through Social Media in Ukraine at the Ministry of Education and Science and Coordination Centre for Legal Aid at the Ministry of Justice of Ukraine.

## Strengthening the Cooperation between the University of Applied Sciences and Arts of Southern Switzerland and Kyiv National University of Technologies and Design, Ukraine

On 3 November 2016 at the Kyiv National University of Technology and Design (KNUTD) results of the REPIC<sup>1</sup> Project "Enhance energy efficiency of the housing stock in Ukraine (EEEU) performance through energy certificates" were presented and discussed at a round-table. This implemented project was collaboration between the KNUTD and the University of Applied Sciences and Arts of Southern Switzerland (SUPSI). The culmination of this event was the ceremonial signing of the Memorandum of Cooperation between the SUPSI and the KNUTD.

This Memorandum specifies further development of the educational, scientific and technical cooperation programme on issues related to the sustainability of the built environment for increasing energy efficiency (EE) and promoting new energy consuming culture in the society; enhancing the expertise and skills in the public sector through the exchange of information, best practice and joint scientific research, training programmes, dissemination of knowledge about modern trends and new methodologies, and technical assistance to projects in the field of energy efficiency. Furthermore, under the signed memorandum both universities agreed to:

- Establish a joint training course for energy managers;
- Advance their mutual collaboration in providing the energy certification of buildings of the KNUTD;
- Develop the thermal modernisation project for one of the KNUTD's university buildings using Swiss technologies;
- Organise the exchange of students and scientists;
- Jointly participate in the development of the Ukrainian National Programme "Energy Efficient University".

# The Agreement on Cooperation between the Taras Shevchenko National University of Kyiv, Ukraine and Heilbronn University, Germany is Signed

In November this year the Agreement on cooperation between the Taras Shevchenko University of Kyiv (SNUK) National Heilbronn University (HU), Germany, was signed in Kyiv. The event takes its roots from the forum "German-Ukrainian dialogue: Prospects Education and Research" held in Berlin in July this year, which was organized by the Federal Ministry of Education and Research of Germany. This Agreement envisages cooperation in areas of student and faculty exchange, as well as joint research projects. For HU, its Faculty of particular, International Business in agreement is very important. One of the five undergraduate programmes of the Faculty, namely "International Business-Eastern Europe", is aimed at training managers with a wide range

of competencies in economics, business, intercultural communication and foreign languages, who are able to work in international business environment in general, and with a focus on Eastern European markets in particular. The Programme's regional specialisation offers an excellent basis for capacity building in Eastern European countries, particularly in Ukraine. Thanks to this cooperation, students from Germany will now have an opportunity to spend an exchange semester at one of the most well-known Ukrainian universities - SNUK, namely at its Institute of International Relations. The broad range of its B.Sc. and M.Sc. Programmes offered both in Ukrainian and English ensures excellent opportunities for such exchange. Already in the winter semester 2016/2017 four German students will spend their exchange semester in Kyiv. The first Ukrainian exchange-students will be admitted by HU in spring 2017. Moreover, new ideas and concrete steps for collaboration in the area of Sustainable Tourism Development were also discussed, with the aim of involving further partners from the SNUK's Faculty of Geography and HU study programmes in "Tourism Management" (B.Sc.) and "International Tourism Management" (M.Sc.). The Faculty of International Business (HU) is now developing an application for the inclusion of SNUK in the ERASMUS<sup>+</sup> programme, which, if successful, will further contribute to expanding this cooperation.

With this agreement the Faculty of International Business (HU) adds an important partner to its expanding portfolio of partner universities (currently 84) in the USA, Canada, France, Finland, Poland, and this cooperation with the Ukrainian university will open new horizons for strengthening the German-Ukrainian dialogue in science and education.





# University of Applied Sciences Lübeck & National Chernivtsi University cooperate on 'Historical City' By Helmut Offermann, FH Lübeck, Germany

Summary: University of Applied Sciences Lübeck has cooperated with the National Chernivtsi University on the project "Practice-oriented Partnership Historical City". Within the framework of this partnership 7 study visits from Chernivtsi to Lübeck took place, as well as visits to Chernivtsi. A number of joint workshops, reciprocal student exchanges were successfully carried out. In December 2016 high-ranking representatives from 6 Ukrainian universities for building & architecture and representatives from Lithuanian, Polish and Romanian higher education institutions came to Lübeck for a Networking meeting to discuss possible future joint projects. This project was supported by the German Academic Exchange Service (DAAD) from the funds of the Federal Ministry for Cooperation (BMZ), from 2013 till the end of 2016./ Das 7. und letzte Bautreffen fand im Oktober 2016 statt. 22 Angehörige der Nationalen Universität Chernivtsi nahmen an der Studienreise nach Berlin und Lübeck teil. Zum Programm gehörte ein Master-Entwurfsworkshop zum Thema "Stadtwärts – Wege zur Stadt", welcher in Kooperation mit dem Projekt-Wirtschaftspartner ArchitekturForum Lübeck e.V. von der FH Lübeck organisiert wurde. Im Workshop arbeiteten ukrainische und deutsche Studierende in Teams zusammen. Die Ergebnisse wurden öffentlich präsentiert. Zwei ukrainische Gaststudentinnen verbringen das Wintersemester 2016/17 in Lübeck: Yulia Balakhtar und Inna Kravchenko. Parallel zum Studium im Fachbereich Bauwesen der FHL absolvieren sie Praktika in den Lübecker Büros GPK Architekten und Haufe Petereit Architekten. Die Betreuung außerhalb der FH Lübeck übernimmt traditionell das ArchitekturForum Lübeck e.V. Zum ersten Mal fuhr für ein Praktikum ein Lübecker Architektur-Student Falk Zepmeisel (giz-Projekt "Integrierte Stadtentwicklung") und Stanislav Bass als Bauingenieur-Studierender (in einer örtlichen Baufirma) nach Chernivtsi. Zwei Dozenten der Fakultät Architektur, Bauingenieurwesen und angewandte Kunst der Nationalen Universität Chernivtsi kamen für mehrere Monate in den Fachbereich Bauwesen. Ziel ist die persönliche Weiterbildung und eine bessere gemeinsame Kommunikation zwischen beiden Hochschulen. Außerdem, Anfang Dezember trafen sich rund 20 VertreterInnen von sechs ukrainischen Bau-Hochschulen und je einer litauischen, polnischen sowie einer rumänischen Hochschule bei einem Network Meeting in der Fachhochschule Lübeck. Die hochrangigen Hochschulvertreter sprachen über mögliche gemeinsame Projekte. Zu Semesterbeginn gab es erneut eine Projekt-Fotoausstellung im BAUFORUM des FB Bau der FH in Lübeck, um die Bilder der letzten Ukraine-Exkursion zu präsentieren. Das Projekt wird gefördert vom DAAD aus Mitteln des Bundesministeriums für wirtschaftliche Zusammenarbeit und Entwicklung. www.ukraine-bauen.de/home/

## The Ministry of Education and Science decided to establish the Coordination Centre for the Framework Programme "Horizon 2020"

This Coordinating Centre will provide support in resolving issues that arise during projects' implementation, facilitate the representation and communication of interests of Ukrainian participants and provide a platform for the development of a consolidated position and for coordinating activities of the authorities in implementing the programme in Ukraine. Moreover, a dedicated Commission will be established, which will be tasked with the selection of representatives and experts to the programme committees, responsible for the identification of priority research topics put forward for funding within "Horizon 2020" calls.

#### **REPORT: Statistics & Analyses of Ukrainian Participation in HORIZON 2020**

This latest analytical report has been prepared in the framework of the RI-LINKS2UA project by the Institute of Fundamental Technological Research of the Polish Academy of Sciences, in cooperation the Centre for Social Innovation (ZSI, Austria), and the Ministry of Education and Science of Ukraine. Some conclusions: "Signed Association gives Ukraine a unique chance to increase significantly their participation in the H2020. This is evidenced by the results of participation in the first 274 calls where 383 Ukrainian organizations participated in preparation of 604 project proposals (808 participations), expecting EC contribution of 236.95 M€. 67 organizations are in 61 proposals on MAIN LIST (80 participations), with EC contribution of 11.95 M€. In particular Ukraine submitted 75 proposals for project co-ordinations of which 4 were classified for funding (MAIN LIST) with EC contribution of 1.78 M€. These results classify Ukraine on the third place among Associated Countries just after Israel and Norway in both: number of participations and gained EC contribution".

On 12-13 November the already traditional "Days of Sciences" took place in seven Ukrainian cities: Ivano-Frankivsk, Kaniv, Kharkiv, Kyiv, Lviv, Odesa and Zhytomyr. This science popularisation project was launched in 2013 by young scientists of the National Academy of Sciences of Ukraine. This year over 80 scientists and teams of researchers took an active role in presenting their research to an estimated 12000 attendees from the interested public.

The organisers managed to secure sponsorship from a few private companies and organisations, and raised additional funds through a crowd-funding campaign.

On 25-26 November 2016 the first nationwide forum of German teachers and lecturers in schools and universities entitled "Professional Sphere German – German language in school and higher education in Ukraine today/ BERUFSFELDER DEUTSCH – Deutsch in Schule und Hochschule in der Ukraine heute" took place at the National Technical University of Ukraine "Igor Sikorsky Kyiv Polytechnic Institute". The key aim of the forum was to induce a qualitative change in the organisation of teaching foreign languages in Ukraine and contribute to improving the quality of the educational process as a whole, thereby improving skills of future workforce. This forum was organised by the NTI "KPI", Goethe Institute Ukraine, DAAD, German Federal Ministry of Foreign Affairs, Ukrainian Union of Germanic Higher Education and the Association of Ukrainian Germanists and was attended by more than 450 participants.
