Natalia Korniy: "Shedding light onto the black box of protein synthesis".

Natalia Korniy was born in L'viv, Ukraine. She gained her Bachelor's degree in Biology and a subsequent Master's degree in Biochemistry from the Ivan Franko National University of L'viv in Ukraine. During her studies Natalia was distinguished with a Stipend of the President of Ukraine (2009), Honored Student Stipend of the Ivan Franko National University of L'viv (2009 – 2013) and the Victor Pinchuk Fund Scholarship (2012 – 2014). In 2013, she joined the International MSc/PhD Max Planck Research School for Molecular Biology at the Georg August University of Göttingen, Germany. A year later she obtained the Masters of Science degree, supported by the Max Planck Research School Master Fellowship. She then continued as a graduate student in the Department of Physical Biochemistry at the Max Planck Institute for Biophysical Chemistry in Göttingen. Throughout her PhD she has been supported by a PhD fellowship from the Max Planck Society (2015-2016), followed by a PhD Fellowship from the Boehringer Ingelheim Fonds. Natalia is interested in learning languages and keen on poetry, classical theatre and philosophy.

Maryna graduated with LL.B. Degree with Honors from the I.I. Mechnikov National University of Odessa in 2014. She then completed the LL.M. Bohdan Tokarskyj, University of Cambridge: “The Poetry of Becoming: The Exploration of Self in Vasyl Stus's Palimpsests”.

Bohdan Tokarskyj was born in Kyiv, Ukraine. He obtained his Bachelor’s and Master’s degrees in International Law at the Kyiv Institute of International Relations. He then went to study at the University of Cambridge, where he gained Master’s degree in European Literature and Culture (2014-2015). His Master Thesis was supported by a Cambridge-Ukrainian Studentship and distinguished with the Santander Academic Excellence Award. Since October 2015 Bohdan carries out his PhD research at the St John’s College/ University of Cambridge, under the supervision of Rory Finnin, the Director of Cambridge Ukrainian Studies. His PhD research is supported by the Gates Cambridge Scholarship and St. John’s Benefactors’ Scholarship. In the summer 2015, Bohdan with a colleague embarked on a three-month trip around Ukraine and spoke to people from all walks of life (soldiers, volunteers, journalists, IDPs, etc.) to get an understanding of how the country has changed since the war started. Having recorded more than a hundred hours of interviews, they composed the verbatim play “*The Summer Before Everything*” that featured as part of the Hotbed Festival in Cambridge. Bohdan also is a Ukrainian Language Teaching Fellow since two years now and he has also taught a number of lectures on Ukrainian literature and culture at Cambridge.

Ivan Vorotiahin was born in Kyiv. He gained his MSc degree in Microelectronics with honors from the National Technical University of Ukraine "Igor Sikorsky Kyiv Polytechnic Institute". In January 2016 Ivan joined the Materials Modelling research group at the Technical University of Darmstadt for his PhD research in collaboration with the Institute of Physics of NAS of Ukraine. He has published his research in *Acta Materialia*, *Physical Review B*, *Ukrainian Journal of Physics*, among other journals, and presented his research at a number of international conferences, such as the 2016 IEEE International Symposium on the Applications of Ferroelectrics (ISAF) and the 14th International Meeting on Ferroelectrics 2017 (IMF-2017).

Oleksandr Yagensky was born in Lutsk, Ukraine. His interest in life sciences early on brought him in his final high-school year the bronze medal at the International Biology Olympiad in Mumbai, India (2008). He completed his Bachelor’s studies in Biotechnology at the Jagiellonian University in Krakow (Poland), supported by a scholarship of the President of Ukraine (2008-2009) and a Rector scholarship of the Jagiellonian University (2009-2010). Oleksandr joined the International Max Planck Research School for Molecular Biology in October 2012 as a Master student, supported by a stipend of the Excellence Foundation for the Promotion of the Max Planck Society (2012-2013). Particle physicist Lesya Shchutska (ETH Zürich) wins the ERC Starting grant in 2017 competition

With her ERC funding **Lesya Shchutska** will exploit the capabilities of the Large Hadron Collider (LHC) at CERN to search for new particles, so-called Majorana neutrinos. This research is important in the quest to understand the nature of dark matter, it can potentially explain the matter-antimatter asymmetry of the universe and hopefully answer questions about the origin of neutrino masses. With this support Lesya will establish and lead a new multisignature research programme at the CMS (stands for the Compact Muon Solenoid, which is a general-purpose detector at the LHC).

Lesya's interest in physics led her to pursue high-school education in Vinnytsia Physics and Mathematics Gymnasium No. 17. In 2002 she won the Bronze Medal at the International Olympiad in Physics. She graduated the Moscow Institute of Physics and Technology with an MSc degree in Elementary Particle Physics and gained her PhD in the same subject from the EPFL (*Ecole Polytechnique Fédérale de Lausanne*). She carried out her postdoctoral research at

the University of Florida, and since February 2017 she joined the ETH Zürich as a Senior Research Associate. Lesya is the LPC Distinguished Researcher. She joined the CMS at CERN in summer 2012 and since then has been actively searching for a new physics with leptonic final states: strongly and electroweakly produced supersymmetric particles. Since September 2017 she is serving as a SUSY group convener in CMS experiment. Furthermore, Lesya is an active promoter of science: she gave lectures about the CMS detector to Ukrainian teachers within the **CERN Teachers Program** (<https://indico.cern.ch/event/594498/>, please note the next event will take place on **3-9 December 2017**).

USA: 2017 Stanford Bright Award goes to green energy innovators Andrij and Roman Zinchenko

This \$100,000 prize is given annually to recognize otherwise unheralded contributions to global sustainability. Andrij and Roman Zinchenko were distinguished for their work supporting and promoting sustainable energy innovation. "The Zinchenko brothers have galvanized energetic and entrepreneurial people from many different sectors, and their work has helped to create both well-known start-ups and a broad network of like-minded people. They have also had an influence on government policy," said Law School Dean M. Elizabeth Magill. The 2017 Bright Award for Environmental Sustainability will be presented to Andrij and Roman Zinchenko on **November 9, 2017** at **Stanford's Paul Brest Hall**. As part of the presentation, the Zinchenkos will give a public lecture and there will be a panel discussion on "Democratizing Energy: Building Sustainability From the Ground Up," followed by a reception. This event is open to the public.

Ukrainian universities benefit from the ERASMUS+ Program

In the latest 2017 ERASMUS+ mobility call 268 projects submitted by Ukrainian universities have been funded with over EUR 8 million. Through these collaborative projects 2 657 exchange students and university staff will be supported to visit partner universities for study and internship periods, teaching, advancing their professional skills and exchange of best practices.

The 2017 call results for the EU ERASMUS+ Program for Capacity Building in the Field of Higher Education/ Action 2 (Cooperation projects to reform higher education) were announced by the EACEA (Education, Audiovisual and Culture Executive Agency). Eight new projects, with partners from 41 Ukrainian organizations, including 30 higher education institutions, will be funded by the EU with approximately EUR 7.5 million. **Pecarpatian National University named after Vasyl Stefanyk** in cooperation with other Ukrainian organizations and universities from Cyprus, Spain and Poland will make a history by becoming a project coordinator-grant holder in Tempus and Erasmus+ program with the project "Modernization of Pedagogical Higher Education by Innovative Teaching Instruments" (586098-EPP-1-2017-1-UA-EPPKA2-CBHE-JP), with a total of EUR 861.445,00. Other projects will focus on smart cities and logistics, integrated PhD in environmental policy, management and technology, artificial implants for bio-engineering, regional studies on Baltic-black sea connections and agro-food among other topics.

CANADA: New agreement to strengthen Ukraine-Canada research networks

The Ukrainian-Canadian Foundation of Taras Shevchenko (Shevchenko Foundation) and Mitacs, a national not-for-profit research and training organization, announced a new partnership that will allow Ukrainian undergraduate students to participate in research internships at Canadian universities for the first time. From June to September each year, top-ranked Ukraine students will participate in a 12-week research internship under the supervision of Canadian university faculty. Students will be provided with research experience and professional skills training. Interns interested in returning to Canada for graduate studies will be eligible for a Mitacs Globalink Graduate Fellowship.

COOPERATION HIGHLIGHTS

New collaborative project in Public Law between National Taras Shevchenko University of Kyiv and Göttingen University started

On September 21, 2017 the German Law Center of National Taras Shevchenko University of Kyiv in cooperation with the Institute of Public Law of the Göttingen University (Germany) organised a German-speaking workshop within the framework of the first part of the joint project "Conditions of operation of the third branch of government" supported by the Alexander von Humboldt-Foundation. The project will be implemented with the participation of Ukrainian and German lawyers over the next three years. Prof. Dr. Thomas Mann, German Coordinator of the project, director of the Institute of Public Law at the University of Göttingen, delivered a keynote talk. The Dean of the Law Faculty Prof. Ivan Hrytsenko congratulated Professor Dr. Thomas Mann and Prof. Dr. Roman Melnyk, director of German Law Center in the field of Administrative Law on the occasion of the 14-year anniversary of this fruitful cooperation and wished them success in the future.

Ukrainian language research at the HU Berlin: DAAD-scholarship holder Lilia Moskalenko explores historical recordings in Ukrainian

Dr Lilia Moskalenko from the Institute of Ukrainian Language of the National Academy of Sciences of Ukraine came last summer for two months as a DAAD scholarship to the sound archive (*Lautarchiv*) of the Humboldt-Universität zu Berlin, which contains recordings in about 250 languages. She has studied unique archived 45 Ukrainian recordings and the corresponding documents. These recordings originate from war prison camps of the First World War, where Berlin scientists recorded the various mother tongue languages of the war prisoners (the ethics of this research is a separate issue, which needs to be addressed by experts). It requires special linguistic knowledge to classify the different dialects, which might no longer exist, and Lilia Moskalenko brought her profound experience in the exploration of Ukrainian dialects. The value of these recordings is difficult to overestimate, since there are apparently no voice recordings of spoken Ukrainian from the early 20th century in Ukraine.

of four university partnership contracts between the Julius-Maximilians-Universität Würzburg and the Lviv Polytechnic National University (LPNU), the Ivan Franko National University of Lviv (IFNUL), the Danylo Halytsky Lviv Medical National University and the Ukrainian Catholic University (UCU).

The cooperation pursues two main goals: on the one hand, it fosters the establishment of academic cooperation in a broad range of teaching and research subjects, particularly emphasizing the exchange of students and lecturers. On the other hand, it aims to support Lviv Universities with the equipment of scientific laboratories, libraries and seminar rooms, as the financial means of Ukrainian universities are currently rather limited. Since 2014, the JMU jointly with a few supporting business companies have been able to organize six transports with high quality used technical equipment; another transport is currently being prepared. Within the framework of the DAAD scholarship program "Eastern Partnerships", more than ten joint workshops and joint seminars have been carried out in various subject areas during recent years, among them workshops in Mathematics and Informatics, Physics, focusing on Nanotechnologies, Chemistry, Medicine, Economy and Theology.

In addition, research stays were organized for more than 50 Lviv master and doctoral students, which offered them an excellent opportunity to work in research labs and institutions of the JMU and thus gain valuable experiences.

Special attention of the cooperation is put on a **Joint Certificate Program (JCP)** in various topic areas, which has been established by lecturers from both sides and which is offered regularly. Participants who have successfully passed the program obtain a joint certificate of their home university and the JMU with up to 20 ECTS credits. The Institute of Computer Science of the JMU Würzburg, for example, offers JCP-courses in Computational Geometry, Algorithmic Graph Theory, Processing 3D Point Clouds and Stability of Large Scale Nonlinear Systems. Besides, the Faculty of Economy has established a JCP in Computational Economics & Econometrics. In addition, there are various summer school offers. Within the context of these courses, the participants are also provided with information on possible scholarships and grants of DAAD and BAYHOST (BAYHOST is the Bavarian Academic Center for Central, Eastern and Southeastern Europe, which promotes academic exchange between Bavaria and countries in the those regions, including Russia). As a result, several students have now succeeded in obtaining DAAD PhD grants and scholarships to support their study stays in Würzburg. In the field of Church History, the Institute of Eastern Church at the JMU and the Faculty of Theology are closely cooperating with the UCU, with subject consultations taking place regularly on both sides. In addition, the UCU researchers have an opportunity to access Würzburg libraries and carry out

research stays in Würzburg. Currently, an exchange program for students via Erasmus+ is being launched.

It is anticipated that this fruitful cooperation will be further advanced in the future.

Ivano-Frankivsk Researchers are the Winners of the Instrumental Access Program

HPLC, CO₂ incubators, microplate readers, inverted microscopes, PCR machine, Hamilton syringes, metabolic cages for mice, and numerous other big and small items - all this equipment will soon become reality at the department of **Biochemistry and Biotechnology of the Vasyl Stefanyk Precarpathian National University (PNU) in Ivano-Frankivsk**. This windfall resulted from the department's successful participation in the Equipment Access program of the **Seeding Labs** (Boston, USA). The goal of this NGO is to support the research laboratories in the countries, where scientists as a rule could not afford modern research equipment. It collects the donated new and used functional instruments and then redistributes it through a competition among the laboratories worldwide that require it most and prepare a convincing research program. The participating lab has to bid for US\$100 thousand worth of scientific equipment, with US\$ 25,500 required to be contributed by the receiving lab. Department of Biochemistry and Biotechnology of the PNU became one of the 15 winners out of 65 applicants in 2017 selection round, the first ever Ukrainian institution to win such a grant. To make their participation possible, a successful crowd-funding campaign to secure the needed US\$ 25,500 thousand was carried out.



"Within last few years substantial changes happened at our department: we have already started new collaborations and adding new projects to the existing ones," – says the head of the PNU Biochemistry and Biotechnology Department, Dr Volodymyr Lushchak. *"We work together with Prof. Olga Garaschuk from Tübingen University on aging of mouse brain within a Volkswagen Foundation supported project, just started a new collaboration with Dr Tetyana Yevsa from Hannover Medical Center, - to study biochemical and immunological processes in mice during aging and under the influence of high fat and restricted diets, supported by the DAAD. We are currently mastering hybridoma technique and have just received a new proposal for collaboration on tissue regeneration experiments. Another line of inquiry is working with plant tissues micropropagation."* The final selection of the Seeding Labs equipment items would partially depend on the needs of current and future collaborations at the department.

The Ivano-Frankivsk team is at the moment in the process of selecting the individual items on their equipment wish-list. *"We hope to get the equipment shipped to us by mid-November. We should be able to get it into Ukraine, custom-clear it and unpack it at the University before year 2018 starts. We really hope so!"* – says Ouliana Djaman, the initiator of the collaboration with the Seeding Labs. This organisation is more than just a donor. The company staff is helping with everything, even hunt for the pieces of equipment the recipient lab needs the most, if such an instrument is absent in the Seeding Labs inventory. It would be a partner of the Ukrainian lab for the next three years. *"We at the department are enthusiastic about the collaboration with the Seeding Labs. I would highly recommend other under-equipped Ukrainian universities to apply for the program. We would keep updated everyone interested in it and answer any questions",* – stresses Ouliana. The idea to take part in the Seeding lab competition "Instrumental Access" arose at the First German-Ukrainian Summer School in July 2016 „Perspectives for young scientists in life sciences: Mastering global challenges of the modern society" (see this Newsletter No 5, July-August 2016, p. 5). In particular, Dr Tetyana Yevsa's (Hannover Medical School/ the UKRAINE Network) support provided the much needed impetus, which resulted in this success. Halyna Semchyshyn and Dmytro Gospodaryov, members of the department, worked tirelessly to make the participation in the Instrumental Access Program possible. Congratulations to the whole team!

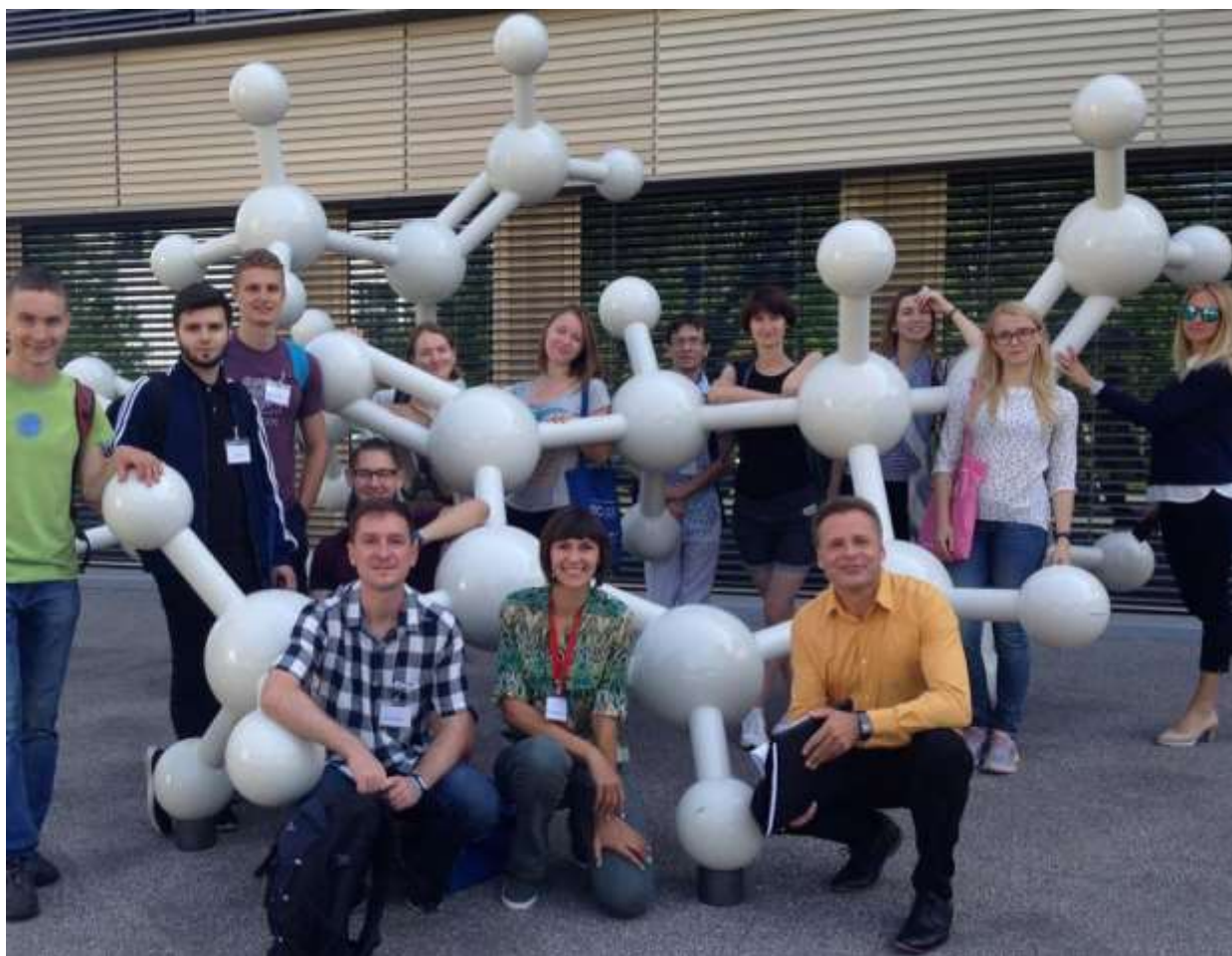

The goal of this summer school was to offer an opportunity to the talented young researchers from Ukraine to learn more about the fundamentals of technology transfer and commercialization of research, further develop their own innovative ideas and explore the business potential of their projects, as well as to provide hands-on training and practical skills through elevator pitch-style presentations in front of business representatives. 13 participants, selected based on the presentations of their innovation project ideas in Kyiv in May and June 2017, had an excellent opportunity to learn from the experts (technology transfer professionals, start-up company founders, managers and investors) about the basics of the business plan development and received helpful tips on protecting intellectual property rights and business development strategies. In addition, the participants had a chance to visit the office of the young company *Labfolder* in Berlin. "Both the participants and lecturers have evaluated this event very positively," says Dr Ulrich Scheller, Managing Director of BBB Management GmbH and an alumnus of the V. N. Karazin Kharkiv National University, Ukraine, "so now we have decided to include this Summer School as a regular offer into the training and further education program of our *Gläsernes Labor Akademie*/Glass Laboratory, <http://www.glaesernes-labor-akademie.de>." VIADRINICUM 2017: "BorderLab. Borderland Experiences: Conflict, Dialogue, and the Arts", Frankfurt (Oder), 28 August – 10 September

Viadrinicum is an annual summer school devoted to the countries of the Eastern Partnership region with a special focus on Ukraine. This year its aim was to tackle the issues of borders and borderland regions from multiple theoretical and methodological perspectives. The school seminars and workshops were devoted to theoretical and empirical analysis of the role of borders and identity construction in conflict areas of the Eastern Partnership region. 30 participants of the school from 14 countries (Germany, Ukraine, Armenia, Poland, Turkey, Italy, USA, Spain, Georgia, Canada, Aserbajdschan, Russia, UK and Switzerland) had a chance to follow the exciting program, which featured the opening talk by Karl Schlögel (Berlin, Frankfurt/Oder), seminars and workshops, including "Trespassing Europe: Wars and Walls in the Borderlands" by Vasyl Cherepanyn (Kyiv), "Construction of Identities in Conflict Zones. Case Study of Abkhazia", by Ketevan Khutsishvili (Tbilisi), Workshop on Conflict Management and Peace Mediation by Lars Kirchhoff (Frankfurt/Oder), Tatiana Kyselova (Kyiv) and Julia von Dobeneck (Frankfurt/Oder), Workshop on Civic Journalism in Areas of Conflict by Jutta Sommerbauer (Vienna) and Elena Jerzdeva (Berlin), among others. Besides the academic part, the participants were also able to develop their own small projects in the framework of three workshops (*Border.Doc*, *Border.Art*, *Border.Media*) under the guidance of professional experts from the field of documentary filmmaking, art and journalism. During the two weeks, non-Ukrainian participants had the opportunity to improve their Ukrainian language skills in classes

of various levels while Ukrainian participants could attend a German language class. Furthermore, the program was accompanied by film screenings and public discussions. Міжнародна літня школа “Viadrinicum”

28 серпня – 10 вересня 2017 року у німецькому місті Франкфурт-на-Одері на базі Європейського Університету “Віадрина” проходила щорічна міжнародна літня школа “Viadrinicum”. Основний напрямок школи пов’язаний із представленням різноманітних питань з історії, культури, політики країн так званого “Східного партнерства”, однак особливий вектор досліджень скерований саме у бік України. Цьогорічною темою організатори школи обрали феномен пограниччя і об’єднали курс лекцій, практичних семінарів і занять у цикл під назвою “BorderLab. Borderland Experiences: Conflict, Dialogue, and the Arts”. Реалізації завдань „Viadrinicum” дуже сприяло місце його проведення – на німецько-польському кордоні над річкою Одер, по два береги якої лежать німецький Франкфурт і польські Слубіце, що метафорично об’єдналося в особливу назву “Ślubfurt”. Учасниками Школи стали понад 30 молодих дослідників із 14 країн світу (Німеччина, Україна, Вірменія, Польща, Туреччина, Італія, США, Іспанія, Грузія, Канада, Азербайджан, Росія, Англія, Швейцарія), які протягом двох тижнів дискутували про нові і старі кордони в Європі, обговорювали шляхи подолання політичних конфліктів на прикладах Абхазії, Придністров’я і Донбасу, створювали власні проекти, направлені на розуміння соціокультурної передусім природи і специфіки поняття пограниччя. Наприкінці “Viadrinicum” кожний з учасників (індивідуально чи у групі) у вигляді мистецьких акцій (наприклад, «пошуки духовних скарбів» на острові поміж двома країнами), есеїв-роздумів чи короткометражних фільмів представив своє бачення концепції пограниччя у сучасних реаліях. Гостями і лекторами Viadrinicum стали знані європейські науковці-історики, філософи, політологи, соціологи, етнографи і культурологи. У рамках Школи проводилися також курси української та німецької мов.
