# **COOPERATION HIGHLIGHTS**

#### Berlin-Odesa Dialogue in Economics: five years of successful cooperation

The cooperation between the Freie Universität Berlin (FUB) and Odessa National I.I. Mechnikov University (ONU) exists since 2017 and was initiated with the exchange visits of scholars as part of the Erasmus + worldwide network. The FUB and ONU since then have been growing academic and student exchanges, and in 2019 ONU was chosen by the FUB as a partner university it their application for the Leonhard

Euler Program, administered by the German Academic Exchange Service (DAAD). Leonhard Euler Program supports doctoral and graduate students from East-European countries, including Ukraine. FUB is constantly striving for new cooperation opportunities in the post-Soviet space and the Leonhard Euler Program is a useful funding instrument for establishing and developing partnerships with universities in Eastern Europe, including Ukraine. Prof. Dr. Theocharis Grigoriadis, Institute for East European Studies, leads this collaboration from the FUB side and ONU is represented by the Department of World Economy and International Economics via Prof. Dr. Serhiy Yakubovsky and Dr. Tetiana Rodionova. Since 2019 joint applications from FUB and ONU for the Leonhard Euler Program were supported by DAAD for already 3 consecutive years. In 2019/2020, the supported doctoral and master students spent one month in Berlin and prepared their research theses for defense under the mentorship of Prof. Dr. Grigoriadis, benefited from the access to the FUB library and got to know rich German culture and university life. The coordinators from the Ukrainian side came to a final presentation of the students' work and provided valuable comments and feedback to improve their theses, as well as discussed further steps to deepen the cooperation between

the universities. One of the results of this fruitful cooperation is that all students involved successfully defended their theses with distinction upon their return to ONU.

In the academic year 2020/21, the project had to be adapted in a view of the Covid-19 pandemic and, regrettably, the research visit to Berlin was canceled. Nevertheless, the project was successfully implemented and completed, with students finalizing their master's theses using online meetings with their academic advisors from both partner universities. Master theses had to be presented and defended online. Moreover, results of their research were published in Ukrainian scientific journals.

Since many years mathematicians from the Institute of Mathematics, Ukrainian National Academy of Sciences in Kyiv and from the University of Potsdam have been involved in mutually beneficial collaboration. Importantly, an Agreement on research, educational and cultural cooperation was signed in 2012 between the Faculty of Science of the University of Potsdam and the Mechanics and Mathematics Faculty of the Taras Shevchenko National University of Kyiv. As a former Ukrainian Humboldt Fellow Prof. Alexandra Antoniouk visited Germany regularly. In particular, she collaborated with Prof. Dr. N. Tarkhanov from the University of Potsdam. During these visits she had the opportunity to explore joint research interests with Prof. Sylvie Roelly, who leads the Chair of Probability Theory, and with members of her research group.

Sylvie Roelly is actively engaged in scientific research with Ukrainian colleagues since several years, in particular with Prof. Andrey Pilipenko who is a leading researcher in the research group of Theory of Random Processes at the Institute of the Mathematics. He often visited University of Potsdam (together with his collaborator Olga Aryasova), gave invited talks and taught a course "An introduction to stochastic differential equations with reflection" to advanced students, which was published by the Potsdam University Press in 2014. As a further development, Dr. Antoniouk and Dr. Pilipenko joined their research efforts and applied for a Research Group Linkage grant to the Alexander von Humboldt Foundation. Their proposal in the field of Analysis and Probability Theory was supported for the period 2018-2021. Thanks to this grant, the research potential at both places can be significantly increased on the following topics: Functional limit theorems for perturbed random walks, Smoothing of non-regular stochastic differential equations and Diffusions in singular domains. Junior researchers from Ukraine: S. Bodnarchuk, O. Prykhodko and T. Kosenkova profit from this intensive international exchange.

Indeed, Probability theory and Stochastic Analysis have a long and famous tradition in Ukraine, in particular due to the former work of Prof. B. Gnedenko, I. Gikhman, A. Skorokhod and M. Yadrenko. Until now this mathematical domain is well represented in Kyiv with very active research groups at the Academy of Sciences and at several universities. Young Ukrainian researchers are well educated in fields like Analysis, Stochastic Processes, Mathematical Statistics and other related fields.

The cooperation started in 2008 when among others HU and TSNUK became partners in a joint Erasmus Mundus consortium. During the following 10 years, joint projects focused mainly on the exchange of students and PhD candidates from Slavic studies and social sciences.

In 2018 we changed the partnership into a bilateral connection within the program line Erasmus 107. We applied successfully for the funding period 2018-21. The involved subjects are social sciences, biochemistry and Slavic studies. This time we broadened the focus and did involve not only students (an overall of 4 persons, with 2 students hosted at each partner university), additional to that we could nominate 2 scientists from the Slavic studies to go to Kyiv and support 2 MSc students to carry out their Master thesis research at the Max Delbrück Center for Molecular Medicine in the Helmholtz Association (MDC) for a whole semester. Moreover, in August 2019 a delegation of Ukrainian researchers and science managers from the Institute of High Technologies (IHT) of TSNUK visited the MDC and HU. In addition to the research talks and visits to scientific technology platforms at the MDC and its Campus Berlin Buch neighbor Leibniz-Forschungsinstitut für Molekulare Pharmakologie (FMP), Kyiv visitors also met and had in-depth discussions with a broad range of science managers from the HUB International Office and Quality Management Department, MDC Graduate School and Postdoc Office, Office for Scientific Infrastructures and Technology Platforms, Department for Strategic Cooperations and Research Funding, MDC "Labor trifft Lehrer" program, Campus Berlin-Buch GmbH and the "Gläsernes Labor". To further develop cooperation in October 2019, Prof. Michael Bader, Head of the Lab "Molecular Biology of Peptide Hormones", MDC and Dr. Natalia Alenina from the same research team were invited speakers at the biomedical forum BioMedTalks- 2019 organized for students

and young scientists of the TSNUK. Moreover, in September 2019, a TSNUK graduate student Anastasiia Sholoh joined the group of Dr. Enno Klussmann, MDC, selected through the competitive International PhD Program at the MDC.

We successfully applied again for the funding period 2020-23. Unfortunately, due to the corona-pandemic we could not realize the projects but we have plans to nominate 1 HU student from the Slavic studies to spend a semester in Kyiv and intend to continue the cooperation with the MDC.

#### **Collaboration in the field of Public Health**

Global trends, such as the adoption of the European Action Plan for Strengthening Public Health Capacities and Services, which laid the foundation for the development of the Public Health system in the European region, and the insufficient level of respective health programs in Ukraine caused a strong need to train professionals capable of developing and implementing such programs in Ukraine. Towards this end many important events have been organized and successfully conducted by Akkon University for Human Sciences in close cooperation with Ivan Horbachevsky Ternopil National Medical University (TNMU): Summer School in Ternopil (2019);

- Skype Lectures given by Prof. Timo Ulrichs (2019, 2020);
- Participation of TNMU students and faculty in the World Health Summit (2019);
- Participation of TNMU students and faculty in the 2nd German-East European Healthcare Symposium (2019) and in the International Symposium of Young Scientists on Global Health in Berlin, Germany, hosted by the Akkon University for Human Sciences (2019, 2021), First (2019) and Second (2020) International Ukrainian-German Public Health Symposiums;

 German-Ukrainian Webinar-Series on combating COVID-19 and on the health system response to the SARS-CoV-2 pandemic in Ukraine, Germany and the world (2020–2021).

Apart from the organizers, faculty and students, high ranking government representatives took part in these events, including the Director General and the Head of the Department for Coordination of Educational Programs of the Public Health Center of the Ministry of Health of Ukraine, representatives of Public Health departments of Ukrainian universities and public health centers. Special attention was paid to the development of human resources for the Public Health system in Ukraine and current issues of Public Health development in Ukraine. Participants also discussed current challenges and future developments of Public Health in both social and academic areas.

In 2019 this fruitful collaboration led to the establishment of the Joint Master Program in Public Health. In cooperation with the Akkon University for Human Sciences TNMU developed an educational-professional program for training of Master-level students in Public Health for the first time in Ukraine and started the training. In 2021, this Public Health program was successfully accredited. In June 2021, the state certification of Public Health students was completed and the first students graduated with a Master's degree in Public Health from the TNMU. Such cooperation between educational institutions of both countries is extremely important and became even more valuable during the COVID-19 pandemic. It is vital for the establishment of the appropriate scientific and educational base, which offers prospects for professional development for teachers, young scientists and students as well as provides them with an opportunity to participate in joint projects and events in the field of Public Health in Germany and Ukraine.

#### **KEYNOTE SPEAKER**



PROF. DR. SERHII PLOKHII Mykhailo S. Hrushevs'kyi Professor of Ukrainian History/ Director Ukrainian Research Institute (HURI) Harvard University USA



Serhii Plokhii is an internationally leading authority on Eastern Europe and Russia. He has published extensively on the international history of Cold War. His books won numerous awards, including the Lionel Gelber Prize (Canada) for the best English-language book on the international relations for *The Last Empire: The Final Days of the Soviet Union* (2014), Taras Shevchenko National Prize (Ukraine) for *The Gates of Europe: A History of Ukraine* (2015), and Ballie Gifford Prize and Pushkin House Book Prize (UK) for *Chernobyl: History of a Tragedy* (2018). His latest book, *Nuclear Folly: A History of the Cuban Missile Crisis*, was released in April 2021.

Plokhii leads a group of scholars working on MAPA: Digital Atlas of Ukraine program, undertaken by the Ukrainian Research Institute at Harvard University and its partners. It brings the latest innovations of information technology to studies of modern Ukrainian history and contemporary political geography. In addition to own research, scholars and students within Harvard community and beyond are encouraged to use Geographic Information Systems (GIS) for illustrating and explaining economic, historical, political, and social transformations within Ukraine using spatial and temporal analysis. The flagship projects include modules on Holodomor – the man-made famine in Ukraine in 1932-1934; Revolution of Dignity (2013-2014); the ongoing war in Donbas, and most recently, the Chernobyl nuclear disaster and its consequences.

## PHD CONTEST FINALISTS



Thousands of students from Ukraine study and receive research training abroad. Many PhD students also work on joint bi-lateral or international collaborative projects, and some carry out research on topics related to Ukraine – e.g. its history, language, etc. Since 2016 the UKRAINET PhD Thesis Presentation Contest promotes these young scientists and in doing so contributes to increasing the visibility of Ukrainian PhD students abroad and raising the profile of the international academic collaboration with Ukraine.



#### **PROF. DR. OLGA GARASCHUK** Chair for Neurophysiology

Chair för Neurophysiology Eberhard Karls University of Tübingen Tübingen, Germany

Olga Garaschuk holds the Chair for Neurophysiology (W3) at the Eberhard Karls University of Tübingen since 2008. She is an elected member of Academia Europaea; Chair of the PhD program "Experimental Medicine" at the University of Tübingen; a Board member of the Erwin-Riesch-Foundation; a Member of the steering committee at the Werner Reichardt Centre for Integrative Neuroscience at the University of Tübingen; a Member of the scientific advisory board of the Center of Advanced European Studies and Research (Bonn), a scientific reviewer of the MRC Laboratory of Molecular Biology (Cambridge, UK); a scientific advisory board member of the Bernstein Centre for Computational Neuroscience and Bernstein Focus Neurotechnology (Göttingen University) and a Mentor at the Helmholtz Leadership Academy. Her research (supported by e.g. DFG, VolkswagenStiftung, Alexander von Humboldt-Stiftung and Horizon 2020) focuses on (i) functional analysis of neuronal networks in vivo, especially in context of perception of sensory stimuli; (ii) interactions between the nervous and the immune systems of the brain as well (iii) aging and neurodegeneration (in particular, Alzheimer disease). Among her scientific achievements

is development of several techniques for functional in vivo imaging of neural networks, pioneering research on in vivo  $Ca^{2+}$ -signaling in microglia (a type of neuroglia (glial cell) located throughout the brain and spinal cord) as well as adult neural stem cells.

Olga Garaschuk graduated in physico-chemical biology from the Moscow Institute for Physics & Technology (MFTI) with top honors. She gained her PhD at the Bogomoletz Institute for Physiology in Kyiv in 1992, and moved first to the Max Planck Institute for Biophysical Chemistry in Göttingen and thereafter to the Institute of Physiology at the University of Saarland, where she was awarded the Irène Curie habilitation Scholarship. She habilitated in Physiology at the Ludwig-Maximilians University, Munich in 2003. Before moving to Tübingen Olga Garaschuk was appointed as Professor for Neuroimaging (W2) at the Institute of Neuroscience of the Technical University in Munich (2006).

Olga Garaschuk co-founded the UKRainian Academic International NETwork (UKRAINET), in 2015, and the German-Ukrainian Academic Society (DUAG), in 2016, and she has been serving as DUAG president since. There, his research interests include: healthcare system development and medical aspects of humanitarian aid as well as global health security aspects. In addition, he heads the section of tuberculosis (TB) at the Koch-Metchnikov-Forum, and is active in various German-Russian/ Eastern European collaborative projects. In the Institute for Global Health Berlin, he contributes to think tank projects as well as links between science and politics.

Professor Ulrichs worked in the division of international health politics of the German Federal Ministry of Health from 2006 to 2012. Besides his scientific work and publications, he is very active in improving microbiological diagnostics and therapy of TB in successor states of the former Soviet Union. In Moldova and Georgia, he contributes as member of faculty (Associate Professor) to medical and public health education. In addition, he organises exchange programs for students and young scientists and seminars with these countries, especially with Ukraine, as well as a symposium series for further education of scientists and physicians in the field of global health.

# **7 OEI** 1951-2021

### The Institute for East European Studies (IEES)/ Osteuropa-Institut at Freie Universität Berlin

The Institute for East European Studies (IEES) at Freie Universität Berlin covers both social and cultural sciences, including history. The Institute is characterized by the interdisciplinarity of its research on Eastern Europe that combines area expertise with theory-based approaches from social and cultural sciences. The range of disciplines, particularly the importance attached to social sciences, and the relative size of the faculty are unique in Germany and create an excellent environment in which to implement the research profile.

The Institute for Eastern European Studies was opened at the FU Berlin in November 1951, three years after the founding of Freie Universität. The establishment of a separate institute for the study of Eastern Europe was a programmatic signal: the aim was to establish research on Eastern Europe that was able to free itself from the old tendencies of the national socialist-oriented "Ostforschung" – and at the same time, in view of the new realities of the Cold War, had to find a place in the changed world and academic order. To meet these challenges, a structurally new organizational form was chosen that was characterized by interdisciplinarity and multidisciplinarity and combined policy advice with basic scientific research. The founding professors Werner Philipp (History), Walter Meder (Law), Erich Kosiol and Karl



Thalheim (Economics) as well as Max Vasmer (Slavic Studies) played a central role in this. A little later, further departments were added for art history, medicine, regional studies, education and sociology.

In addition to academic work in research and teaching, the aim was to make the knowledge acquired accessible to a broader public and, as Ernst Reuter demanded at the ceremony marking the opening, to create an awareness that the countries behind the Iron Curtain "belonged to Europe and that the Institute should contribute to forging a bond with the Eastern European peoples and point the way to a better future." The Osteuropa-Institut is still committed to this mission today.

The Osteuropa-Institut's seventy-year history is a mirror of Berlin's and Germany's changeful relations with its eastern neighbors in the 20<sup>th</sup> and 21<sup>st</sup> centuries. The turbulent founding phase, during which very different people and positions were brought together, is as much a milestone for this as the period of student protests at the end of the 1960s and the years of system collapse and system transformation since the 1990s. In the course of these massive changes, the Institute itself also changed along with Eastern European Studies. Through the fall of communism, it came under massive pressure to justify itself and fought for its existence for years. Today, the Institute is once again a central location for international research on Eastern Europe.

### The German-Ukrainian Academic Society (Die Deutsch-Ukrainische Akademische Gesellschaft e.V., DUAG)



The German-Ukrainian Academic Society (DUAG) was founded in Berlin in 2016 and registered as a not-for-profit non-governmental organization (eingetragener Verein, e.V.). The goals of the Society align with the overarching goals of the UKRainian Academic International NETwork (The UKRAINE Network, or UKRAINET for short), specifically in the context of the German-Ukrainian academic cooperation:

- Foster academic cooperation with Ukraine;
- Improve knowledge about Ukraine abroad and vice versa;
- Increase visibility of Ukrainian scientists and their achievements;
- Support career development of its members and early-career researchers in Ukraine;
- Support reforms in science in Ukraine.

One of the key tasks of the Society is the establishment of a dialogue and cooperation platform aimed at facilitation of networking, best practice exchanges, and providing support to those researchers in Germany and Ukraine, who are interested in bi-lateral and multi-lateral cooperation in higher education, science and research. Thus, DUAG fosters the internationalization of the Ukrainian science and higher education system, enables knowledge transfer and contributes to capacity building.

As of 1 August 2021, the Society unites 68 members with almost equal distribution among different broadly-defined research areas of exact & natural sciences; life sciences & medicine; and social sciences, arts & humanities.

In a recent DUAG-supported project initiated by the Union of Ukrainian Students in Germany (Bund Ukrainischer Studenten in Deutschland e.V. BUSD e.V./ CYCH) "Education Inside Out Germany-Ukraine" many DUAG members gave video-interviews describing their career pathways and sharing insights in education and research cultures in Germany and Ukraine.

# **The Goals**



Two new funding lines aim at intensifying academic exchange with the countries of Eastern and South-eastern Europe, the South Caucasus and Central Asia: the **Go East -Eastern Europe Days** at German universities and the **Go East - Project Initiation Trips** in the regions of South Caucasus and Central Asia.

As **Go East - Eastern European Days**, small information events as well as larger bilateral university days are supported.

The Go East - Project Initiation Trips serve to intensify contacts with higher education institutes in the South Caucasus and Central Asia regions. Trips for German professors and other university members are funded. Academic opportunities in the South Caucasus and Central Asia regions are diverse. Armenia and Azerbaijan have highly specialised universities in architecture and engineering, for instance. Turkmenistan is home to a large and young university scene. Research is being conducted there on future technologies in the nano-, bio- and information sciences.

The Go East funding lines strengthen the internationalisation of the participating universities and promote academic exchange as equals. They increase the interest of German students and graduates in spending time in countries in Eastern and South-eastern Europe, the South Caucasus and Central Asia.




